**Resolution to Approve Amendment of Contract for Superintendent of Schools**

Board of Education Resolution 22/23: 01

Adopted: July 12, 2022

WHEREAS, by Resolution 21/22: 70 dated February 22, 2022, the Board of Education authorized a contract to hire Dr. Brian Hill as the District’s next Superintendent of Schools; and

WHEREAS, section 3.2.3 Insurance of said contract approved did not clearly define the agreement as to the parties responsibilities for associated costs; now

THEREFORE, be is resolve that section 3.2.3 shall be modified to read as: “The District shall offer health, life, dental, and vision insurance coverage to Hill and his eligible dependents on the same basis as offered to all eligible full-time employees. Such insurance benefits will be paid by the District at no cost to Hill.”; and

NOW, THEREFORE, RESOLVED that the Board of Education of Mesa County Valley School District No. 51 shall employ Dr. Brian Hill as the Superintendent of Schools for the District commencing July 1, 2022, under the terms of the employment contract entered into on February 22, 2022, with the above amended language, and directs the Board President and Secretary to execute said employment contract on behalf of the Board upon execution of same by Dr. Hill.
