Transportation is available to those students who live beyond a designated area from school. Rules and regulations governing transportation are established for the operation of the school busses. Transportation is considered a service provided by the school district and all students must abide by all rules and regulations. **Students who violate rules and regulations are subject to SUSPENSION of their bus riding privileges.** Below are the bus rules and regulations. Please keep them for your reference and sign and return the second page to your student's bus driver.

Bus Rules and Regulations:

- 1. There is video cameras on all buses**
- 2. Any damage on buses by students' are subject to repair charges & or criminal charges subject to the severity of damage.**
- 3. Students are not permitted to take pictures or videos while on the bus.**
- 4. No objects or body parts shall be out the windows!**
- 5. There will be NO TOLERANCE for any behavior which jeopardizes the safety of the driver or passengers i.e. drugs, alcohol, smoking, vaping, exiting rear door, inflicting bodily harm, vandalism, littering or bullying of any kind. Foul language and obscene gestures will not be tolerated.**
- 6. Students are required to follow the bus drivers instructions at all times**
- 7. Students must be prompt at the bus stop. Students should arrive 10 minutes early. When crossing the roadway to meet or leave the bus, students shall wait for the bus driver signal before crossing in front of the bus and must be 10 ft. in front of the bus!**
- 8. Students are to be seated facing forward both feet on or near the floor. They are not to be turned sideways, or in the aisle or facing the back of the bus. Students shall not open or close a window without permission from the driver. Students should remain seated until bus comes to full stop.**
- 9. Respect the driver and other students on the bus.**

10. Students may talk quietly while on the bus. Students must be quiet at all railroad crossings.
11. Students are NOT ALLOWED to have gum, candy, or food on the bus other than and sealable water bottle.
12. Aisles of the bus must be kept clear at all times. No feet, legs, backpacks, jackets etc.
13. Electronic devices, the sound must be off, the use of ONE ear bud is permitted. Students must be able to hear driver at all times!
14. Absolutely NO SPRAYING of any kind i.e. hair spray, perfume, body spray, deodorant etc. Makeup & Nail products are not allowed on the bus
15. If your student is going to have a friend ride the bus they MUST HAVE Parent written consent from each Parent. *You may call your student's school office. The Secretary will write out the students name and bus # to give to driver. We will not allow any students to ride without prior permission!

COVID- 19 Safety Rules and Precautions

Busses will be cleaned and sanitized after every route!

There will be no food allowed on buses. If a medical reasons please contact Transportation before student rides bus. 719-530-5231

Hand sanitizer will be available to every student every time they load and unload the bus.

Masks per DOT/CDC are optional per person, this can be changed and will be enforced if directed to do so.

Windows will be open to insure air ventilation on the bus. During this time the windows will only be operated by the bus driver.

Driver will delegate seating charts as needed. If your child is sick i.e. fever, cough, etc., keep them home, do not send them to school please!!
